- 1) City of Carl's Corner, for a proposed well (#2181) to be drilled in Hill County at 695 Linda Rd., Carl's Corner, Texas 76645; not to exceed 300,000 gal. for 2020 and 21 mg annually thereafter; Municipal Use. (Driller of record: THI Water Well).



Any subject discussed in executive session may be subject to action during an open hearing or meeting.
