Notice is hereby given to all interested members of the public that the Board of Directors of the Prairielands Groundwater Conservation District will hold a public hearing on permit applications and a regular public meeting both in person and via audio and video conference call pursuant to Texas Government Code, Section 551.125, and as modified by the Governor of Texas who ordered suspension of various provisions of the Open Meetings Act, Chapter 551, Government Code, effective March 16, 2020, in accordance with the Texas Disaster Act of 1975. The Prairielands GCD Board of Directors will hold a public hearing on the following application(s) for an OperatingPermit:

- 1. Call to Order and Declare Public Hearing Open to the Public

- 3. Receive permit hearing report from General Manager, receive any public comment(s) or requests to contest, and consider granting, denying, or amending applications for the following Operating Permit:

- Troy Bradshaw, for a proposed Operating Permit for a new well (#2439) to be drilled in Hill County at Highway 171/County Road 1413, Grandview, Texas, 76050; not to exceed 10,050,000 gallons annually; Municipal Use. (Driller of record: TBD)
- 2) Glen Lake Camp and Retreat Center, for a proposed Operating Permit for an existing well (#2502) located in Somervell County at 1102 NE Barnard Street, Glen Rose, Texas 76043; not to exceed 1,500,000 gallons in 2021 and 3,500,000 gallons annually thereafter (→2026); filling a pond or surface impoundment and water park.
- 4. Adjourn or continue public hearing in whole or in part.

At any time during a hearing or meeting of the Prairielands Groundwater Conservation District Board and in compliance with the Texas Open Meetings Act, Chapter 551, Government Code, Vernon's Texas Codes, Annotated, the Board may meet in a closed executive session on any of the above agenda items or other lawful items for consultation concerning attorney-client matters (§551.071); deliberation regarding real property (§551.072); deliberation regarding prospective gifts (§551.073); personnel matters (§551.074); and deliberation regarding security devices (§551.076). Any subject discussed in executive session may be subject to action during an open hearing or meeting.

Persons may make comments for or against an application for any type of permit, permit amendment, replacement well, or exception request without the need to request a contested case hearing on the application. However, persons wanting to protest an application involving a permit or permit amendment by requesting a contested case hearing must do so either in writing or by appearing at the public hearing in person or by video conference or telephone on the date specified in this notice before the time that the Board takes final action on the application, as set forth more specifically in the District Rules.
