



NOTICE OF PERMIT HEARINGS

NOTICE IS HEREBY GIVEN to all interested persons within the Prairielands Groundwater Conservation District, consisting of Ellis, Hill, Johnson, and Somervell counties: That the Board of Directors of the Prairielands Groundwater Conservation District (PGCD) will hold hearing(s) on applications for Operating Permits (OP) by the below listed parties on Monday, July 18, 2022, beginning at 9:00 AM at the District board room located at 208 Kimberly Drive, Cleburne, Texas 76031.

NOTICE is hereby specifically given to:

1. Arlington Stor-More, LLC (North Texas Jellystone Park™) for a proposed Operating Permit for an existing well (PGCD-000376) located in Johnson County at 2600 County Road 602, Burleson, Texas 76028; not to exceed 7,338,000 gallons annually for 2022→2026; Commercial Use for filling a pond or surface impoundment and landscape irrigation.
2. Glen Lake Camp and Retreat Center, for a proposed amendment to an existing Operating Permit (OP-21-010) to add additional groundwater production authorization in the amount of 900,000 gallons; not to exceed 4,400,000 gallons thereafter (→2026).

If granted, the permit(s) requested in the applications above would authorize the permit holder to withdraw groundwater from a water well according to the terms and conditions set forth in the permit. If you would like to contest an application for a permit, you must comply with District Rule 10.6 and either appear at the hearing or submit a written Request for Contested Case Hearing that complies with District Rule 10.6 and that must be received by the District prior to the date of the hearing. A person who submits a written Request for Contested Case Hearing who is unable to appear at the hearing on the date and time set forth above must also timely file a motion for continuance with PGCD demonstrating good cause for the inability to appear.
