**NOTICE IS HEREBY GIVEN** to all interested persons within the Prairielands Groundwater Conservation District, consisting of Ellis, Hill, Johnson, and Somervell counties: That the Board of Directors of the Prairielands Groundwater Conservation District (PGCD) will hold hearing(s) on applications for Operating Permits (OP) by the below listed parties on Monday, September 19, 2022, beginning at 9:00 AM at the District board room located at 208 Kimberly Drive, Cleburne, Texas 76031.

**NOTICE** is hereby specifically given to:

1. City of Whitney for a proposed Operating Permit (OP-22-028) for additional groundwater production authorization in Hill County at 105 W. Cleveland Ave, Whitney, TX 76692; not to exceed 61,313,700 gallons annually for 2022→2026; Municipal Use
2. Undine Texas LLC (Buffalo Creek), for a proposed Operating Permit (OP-22-025) for additional groundwater production authorization in Johnson County at 2308 Bozoki Road, Cleburne, TX 76031; not to exceed 3,304,600 gallons annually for 2022→2026; Public Water Supply
3. Undine Texas LLC (John Dame), for a proposed Operating Permit (OP-22-026) for additional groundwater production authorization in Johnson County at 11707 John Dame Ln, Crowley, TX 76036; not to exceed 1,131,300 gallons annually for 2022→2026; Public Water Supply
4. Arnold Crushed Stone, for a proposed Operating Permit (OP-22-029) for authorization to drill a new well (#2936) to be located in Hill County at 1676 HCR 1104 Loop, Blum, TX 76627; not to exceed 0 gallons in 2022, and 43,887,500 gallons annually thereafter (→ 2026); Manufacturing; (Driller of record: Pollock Water Well Drilling & Service)

If granted, the permit(s) requested in the applications above would authorize the permit holder to withdraw groundwater from a water well according to the terms and conditions set forth in the permit. If you would like to contest an application for a permit, you must comply with District Rule 10.6 and either appear at the hearing or submit a written Request for Contested Case Hearing that complies with District Rule 10.6 and that must be received by the District prior to the date of the hearing. A person who submits a written Request for Contested Case Hearing who is unable to appear at the hearing on the date and time set forth above must also timely file a motion for continuance with PGCD demonstrating good cause for the inability to appear.
