Special Board Meeting to adopt Desired Future Conditions ("DFC") that apply to the Prairielands Groundwater District

The Special Board Meeting to adopt DFC will begin at 9:00 AM. The Notice of Special Board Meeting was posted separately in accordance with the District Rules, and Chapter 36, Texas Water Code, on October 25, 2022.

The Desired Future Conditions for the District are based on the total average number of feet of drawdown in water levels in the aquifers/layers from January 1, 2010, though calendar year 2080. They were adopted on three scales: county by county; for each groundwater conservation district within GMA 8; and aquifer-wide within GMA 8. The three scales do not differ substantively in their application. For the District, the relevant proposed DFCs include the following District-wide average aquifer drawdown numbers through 2080 (expressed in terms of feet of drawdown by aquifer/layer): 44' in Woodbine; 44' in Paluxy; 142' in Glen Rose; 170' in Twin Mountain; 323' in Travis Peak; 201' in Hensell; 364' in Hosston.

County-wide average aquifer drawdown through 2080 of (in feet by aquifer/layer) are as sp;;pws: Ellis County: 76' in Woodbine, 128' in Paluxy, 220' in Glen Rose, 413' in Twin Mountain, 380' in Travis Peak, 290' in Hensell, 390' in Hosston; Hill County: 20' in Woodbine, 45' in Paluxy, 149' in Glen Rose, 365' in Travis Peak, 211' in Hensell, 413' in Hosston; Johnson County: 4' in Woodbine, -57' in Paluxy, 66' in Glen Rose, 184' in Twin Mountain, 235' in Travis Peak, 120' in Hensell, 329' in Hosston; and Somervell County: 4' in Paluxy, 4' in Glen Rose, 50' in Twin Mountain, 64' in Travis Peak, 17' in Hensell, 120' in Hosston.

However, persons wanting to protest an application involving a permit or permit amendment by requesting a contested case hearing must do so in writing in accordance with District Rule 10.6 that is either received by the District or submitted at the public hearing in person before the time that the Board takes final action on the application, as set forth more specifically in the District Rules.
