

NOTICE OF PERMIT HEARINGS

PRAIRIELANDS GROUNDWATER CONSERVATION DISTRICT To be held 9:00 AM, Monday, November 21, 2022

NOTICE IS HEREBY GIVEN to all interested persons within the Prairielands Groundwater Conservation District, consisting of Ellis, Hill, Johnson, and Somervell counties: That the Board of Directors of the Prairielands Groundwater Conservation District (PGCD) will hold hearing(s) on applications for Operating Permits (OP) by the below listed parties on Monday, November 21, 2022, beginning at 9:00 AM at the District board room located at 208 Kimberly Drive, Cleburne, Texas 76031.

NOTICE is hereby specifically given to:

- South Ellis County WSC, for a proposed amendment to an existing Operating Permit (OP-21-017) to add additional groundwater production authorization in Ellis County; not to exceed 20,000,000 gallons annually (→2026); Public Water Supply
- 2. Parker WSC, for a proposed Operating Permit (OP-22-031) for additional groundwater production authorization in Johnson County at 7001 CR 1200, Cleburne, TX 76031; not to exceed 25,000,000 gallons annually for 2022→2027; Public Water Supply
- 3. Somervell County Water District, for a proposed Operating Permit (OP-22-032) for additional groundwater production authorization in Somervell County at 2099 CR 301, Glen Rose, TX 76043; not to exceed 32,591,000 gallons annually for 2022→2027; Public Water Supply
- 4. Woodrow-Osceola WSC, for a proposed amendment to an existing Operating Permit (OP-20-004) to add additional groundwater production authorization in Hill County in the amount of 15,000,000 gallons annually; not to exceed 30,000,000 gallons thereafter (→2025); Public Water Supply

If granted, the permit(s) requested in the applications above would authorize the permit holder to withdraw groundwater from a water well according to the terms and conditions set forth in the permit. If you would like to contest an application for a permit, you must comply with District Rule 10.6 and either appear at the hearing or submit a written Request for Contested Case Hearing that complies with District Rule 10.6 and that must be received by the District prior to the date of the hearing. A person who submits a written Request for Contested Case Hearing who is unable to appear at the hearing on the date and time set forth above must also timely file a motion for continuance with PGCD demonstrating good cause for the inability to appear.
