## MINUTES OF PUBLIC HEARING ON APPLICATION FOR OPERATING PERMIT

The Board of Directors of the Prairielands Groundwater Conservation District ("District") met in a public hearing within the boundaries of the District at 208 Kimberly Dr, Cleburne, TX 76031, on January 22, 2024.

In the absence of the president and vice-president, Secretary/Treasurer Osborn assumed the role of presiding officer, calling the public hearing to order at 9:05 a.m. and announcing the meeting open to the public.

# RECEIVE PERMIT HEARING REPORT FROM GENERAL MANAGER, ANY PUBLIC COMMENT(S), REQUESTS TO CONTEST AND CONSIDER GRANTING, DENYING, OR AMENDING APPLICATIONS FOR THE FOLLOWING OPERATING PERMITS:

- 1. Woodrow Osceola WSC, for a proposed amendment to an existing Operating Permit (OP-20-004A) to additional groundwater production authorization in Hill County in the amount of 40,000,000 gallons; not to exceed 70,000,000 gallons or 235,334,400 gallons annually thereafter (→2025); Public Water Supply (KB);
- Hilco United Services, Inc. (Chambers Meadow Estate Water), for a proposed Operating Permit (OP-23-052) for authorization to produce additional groundwater from an existing well (PGCD-000414) location in Ellis County at 767 South IH 35, Italy, TX; not to exceed 5,000,000 gallons annually for 2023→2027; Public Water Supply (KB); and

3. Crest Water Company (Northcrest Addition), for a proposed Operating Permit (OP-24-053) for authorization to produce additional groundwater from existing wells located in Johnson County at 5415 Burleson Oaks, Burleson, TX; not to exceed 5,136,400 gallons for 2023 and 10,000,000 gallons for 2024→2027; Public Water Supply (AK)

Crest Water Company (Buffalo Hills Water System), for a proposed Compliance Order for authorization to produce additional groundwater for existing wells located in Ellis County at 5160 Antelope Trail, Midlothian, TX; not to exceed 2,645,999 gallons for 2023 and 5,000,000 gallons 2024→2027 above the amount authorized under permittee's existing permit; Public Water Supply (AK)

Motion was made by Director Curtis and seconded by Director McClure to approve the Compliance Order in accordance with the General Manager's recommendation. Motion carried unanimously by all those who were present.
