



NOTICE OF PERMIT AND ENFORCEMENT HEARINGS

NOTICE IS HEREBY GIVEN to all interested persons within the Prairielands Groundwater Conservation District, consisting of Ellis, Hill, Johnson, and Somervell counties: That the Board of Directors of the Prairielands Groundwater Conservation District (PGCD) will hold hearing(s) on applications for Operating Permits (OP) and/or Permit Amendments and enforcement matters by the below listed parties on Monday, January 22, 2024, beginning at 9:00 AM at the District board room located at 208 Kimberly Drive, Cleburne, Texas 76031.

NOTICE is hereby specifically given to:

1. Woodrow Osceola WSC, for a proposed amendment to an existing Operating Permit (OP-20-004A) to add additional groundwater production authorization in Hill County in the amount of 40,000,000 gallons; not to exceed 70,000,000 or 235,338,400 gallons annually thereafter (→2025); Public Water Supply (KB)
2. Hilco United Services, Inc. (Chambers Meadow Estate Water), for a proposed Operating Permit (OP-23-052) for authorization to produce additional groundwater from an existing well (PGCD-000414) located in Ellis County at 767 South IH 35, Italy, TX; not to exceed 5,000,000 gallons annually for 2023→2027; Public Water Supply (KB)
3. Crest Water Company (Northcrest Addition), for a proposed Operating Permit (OP-24-053) for authorization to produce additional groundwater from existing wells located in Johnson County at 5415 Burlison Oaks, Burlison, TX; not to exceed 5,136,400 gallons for 2023 and 10,000,000 gallons for 2024→2027; Public Water Supply (AK)
4. Crest Water Company (Buffalo Hills Water System), for a proposed Compliance Order for authorization to produce additional groundwater for existing wells located in Ellis County at 5160 Antelope Trail, Midlothian, TX; not to exceed 2,645,999 gallons for 2023 and 5,000,000 gallons 2024→2027 above the amount authorized under permittee's existing permit; Public Water Supply (AK)

If approved, the permit(s) and/or permit amendments and the compliance orders requested in the applications above would authorize the permit holder to withdraw groundwater from a water well according to the terms and conditions set forth in the permit or compliance order. If you would like to contest an application for a permit or permit amendment, you must comply with District Rule 10.6 and either appear at the hearing or submit a written Request for Contested Case Hearing that complies with District Rule 10.6 and that must be received by the District prior to the date of the hearing. A person who submits a written Request for Contested Case Hearing who is unable to appear at the hearing on the date and time set forth above must also timely file a motion for continuance with PGCD demonstrating good cause for the inability to appear.
